## Attention all Minnesota Chippewa Tribe (MCT) members

The Minnesota Chippewa Tribe (MCT) will be conducting a survey to help us learn more about the blood quantum of MCT members and their descendants.

We will use the information from this survey to determine what other tribal affiliations (non-MCT) exists within families of enrolled members. However, no enrollment criteria will be changed as the result of this survey – it is for information gathering purposes only.

Approximately 3000 enrolled MCT members will be invited to participate in this study using scientific random sampling – all MCT Band members 18 years of age and older have an equal chance of being selected to participate.

MCT hired Wilder Research to conduct this survey. We will start contacting MCT members in fall 2012. If you are invited, we hope you decide to participate. Your participation and accurate information are vital to the validity and success of this survey. With a completed survey, you will be entered into a

drawing with other survey participants. If you are not selected to participate, but you would like to participate or learn more about the survey, you can visit [www.mnchippewatribe.org](http://www.mnchippewatribe.org).

# A few thoughts from RBC members

## From the Chairwoman

The Band is working with the Bureau of Indian Affairs to set up the accounts necessary to distribute the Nelson Act funds. Once this is finalized, Fond du Lac will get the funds and then we get them into Band member hands. We continue to be hopeful that this will occur before the end of the year.

Members of the community were shocked this month when word got around that a violent crime had taken place on the reservation. Out of the 4 people who are currently facing charges for some role in the

murder of young woman from Floodwood, Minn., two are not Fond du Lac tribal members, and three of the four, are people who had previous to this, been forbidden from Band lands.

A couple of years ago, in response to a drive-by shooting in the area known as the compound, the RBC had several meetings to talk about what the community could do to respond to violence and drugs in the community. At that time, it was asked of the RBC that there be put into place a policy restricting Fond du Lac

housing for people convicted of violent or drug felonies. That was done, and currently there is a 10 year prohibition on residing in Band housing for these types of felons. Additionally, it was decided that the Band's exclusion ordinance should also be applied to Band members who are deemed a threat to the community. This was also implemented.

The community is again wondering if these things are enough to deter crime and create safety. First of all, it should be noted that banned individuals were residing in housing

on Band lands. Band members should be aware that if you harbor individuals who are banned from the Reservation in your housing, that you may end up losing your housing. Secondly, if you are aware of people who are doing unlawful things in the community, please contact law enforcement. Everyone needs to be a part of the solution. Thirdly, ask yourself what you can do within your own families to confront drug use and gang affiliation. Finally, become an active part of your children and grandchildren's lives. Make sure they know to have respect for themselves, their families, and their community. Thank

you to the Band members who had enough courage to take a public stand by having the public marches and meetings. Now the real work begins to create community based change. The RBC is interested in knowing how we can help your efforts.

It seems like bad news never stops. We had a body discovered on the reservation this month. The body was identified as a female that was missing from Floodwood, which is located a few miles west of the reservation. I did not know the person that is accused of doing the crime but, he was banished from the reservation for another act of violence he

had committed prior to this. I did not know the female, but she did not deserve to die like this. The community has come together and marched against violence and drugs on the reservation and it gave me hope to see our community speak out in this manner. They have scheduled community meetings

to address their options on how to make changes in the way we address these problems. I completely support their efforts. I don't know what the magic bullet is, but I do know that the community has to be involved if we are going to be able to solve this problem and make our reservation a safe place for all.

The Nelson Act Settlement has been signed by the presi-

dent. We are in the process of checking all current addresses to make the payment. If you have moved and not corrected your address, please contact the reservation with the proper information. We should be making the payment soon.

We are about to break ground for the veterans supportive housing unit. There are going to be 10 units available for veterans in need of services. If you or someone you know might be

- Have a committed neighborhood watch
- Have an announcement made on radio for when the community meetings will be held.
- Also have them posted on webpage and on the message board at resource management building.

- Why isn't there something done when there is so much traffic going to one home? The police are called but what can be implemented at housing when things like this happen?
- Policy change

The purpose of the meeting is to 1) review recommendations and strategies for increasing the number of American Indian teachers in Minnesota; 2) review components of the state's teacher preparation program specific to teaching all teacher's best practices and American Indian content (American Indian history & culture); 3) create an American Indian Statewide Advisory Committee to monitor all progress and propose alternatives.

Schools receiving funding for the Johnson O'Malley (JOM) Program (Carlton, Cloquet, Superior, Duluth, & Albrook-South Ridge) will be having their student count numbers verified. We want to ensure that student counts are accurate in that the reservation allocates funding based on data received.

## Possession of protected bird feathers

[The U.S. Department of Justice has issued the following memo to clarify rules for possession of federally protected bird feathers and body parts (especially eagles)]

This memorandum formalizes and memorializes the long-standing policy and practice of the Department of Justice regarding the possession or use of federally protected birds, bird feathers, or other bird parts for the cultural and religious purposes of federally recognized Indian tribes. This memorandum also provides background and guidance regarding this policy.

The Department of Justice recognizes that many Indian tribes and tribal members use, and traditionally have used, federally protected birds, bird feathers, or other bird parts for their tribal cultural and religious expression. Indeed, the eagle plays a unique and important role in the religious and cultural life of many Indian tribes. And in light of the important government-to-government relationship that the United States has with federally recognized tribes, the United States has a strong interest in accommodating the interests of these tribes by protecting the ability of their members to meaningfully practice their religions and preserve their cultures.

At the same time, tribes and their members and the United States share an interest in - and a responsibility for - protecting this Nation's scarce and precious wildlife resources. Federal wildlife laws are essential to preserving natural resources - including the eagle and other

migratory birds - that are vitally important to this Nation. It is a federal enforcement priority to prosecute those who violate federal laws by engaging in commercial activities involving federally protected birds, bird feathers, or other bird parts, or by killing such birds without authority under federal law. The objective of these enforcement efforts is to reduce and eliminate the unlawful taking of federally protected birds by prosecuting not only individuals who take protected birds but also individuals who seek to profit from the commercialization of federally protected birds or their feathers or other parts.

In short, the Department of Justice is committed to robust enforcement of federal laws protecting birds while respecting tribal interests in the use of eagle feathers and other federally protected birds, bird feathers, and other bird parts for cultural and religious purposes

### Background

The Department of Justice policy memorialized in this memorandum is consistent with the longstanding policy of the Department of the Interior. In 1975, then-Secretary of the Interior Rogers C. B. Morton issued a policy statement concerning Indian cultural and religious use of migratory bird feathers and parts, which has become known as the "Morton Policy." The Morton Policy was issued to "clarify the Department of the Interior's responsibilities and intentions" as to enforcement, of federal laws protecting eagles and to "ease the minds of American Indians" who had raised concerns about the application of federal wildlife protection laws to their cultural and religious activities.

Pursuant to the Morton Policy, the Department of the Interior has long permitted members of federally recognized tribes to engage in specified activities, including the possession and use of federally protected birds, as well as their parts or feathers, "without fear of federal prosecution, harassment, or other interference." The Morton Policy also affirmed that the government would not permit anyone, including members of federally recognized tribes, to kill federally protected birds without a permit or to engage in commercial trade in federally protected birds, bird feathers, or other bird parts. The government would continue to enforce against all persons federal Laws prohibiting the killing of protected birds and prohibiting commercial activities involving protected birds and their feathers and parts.

The Morton Policy has guided the federal government's approach to enforcement of federal laws protecting birds ever since it was issued. Nonetheless, I understand that there continues to be some uncertainty and concern regarding enforcement of Federal bird protection laws as related to the cultural and religious activities of members of federally recognized tribes. I am therefore issuing this memorandum in order to clarify and confirm that the Department of Justice continues to exercise its prosecutorial discretion in a manner consistent with the Morton Policy.

### Policy

The Department of Justice is committed to balancing enforcement of the Nation's wildlife laws with acknowledgment of the cultural and religious needs of federally recognized Indian

tribes with which the United States shares a government-to-government relationship. This policy is intended to ensure coordination and continued consistency with the Morton Policy and to clarify certain issues not expressly or fully addressed in the Morton Policy itself. The Department of Justice has worked very closely with the Department of the Interior in developing this policy. This policy is intended to ensure a consistent and uniform approach across the nation to enforcement of federal laws protecting birds.

Accordingly, consistent with the Morton Policy and the Department of Justice's traditional exercise of its discretion, a member of a federally recognized tribe engaged only in the following types of conduct will not be subject to prosecution:

- Possessing, using, wearing, or carrying federally protected birds, bird feathers, or other bird parts;
- Traveling domestically with federally protected birds, bird feathers, or other bird parts or, if tribal members obtain and comply with necessary permits, traveling internationally with such items.
- Acquiring from the wild, without compensation of any kind, naturally molted or fallen feathers of federally protected birds, without molesting or disturbing such birds or their nests;
- Giving or loaning federally protected birds or the feathers or other parts of such birds to other members of federally recognized tribes, or exchanging federally protected birds or the feathers or other parts of such birds with other members of federally recognized tribes, without compensation

of any kind;

- Providing the feathers or other parts of federally protected birds to craftspersons who are members of federally recognized tribes to be fashioned into objects for eventual use in tribal religious or cultural activities. Although no compensation may be provided and no charge made for such feathers or other bird parts, tribal craftspersons may be compensated for their labor in crafting such objects.

Members of federally recognized tribes are covered by this policy regardless of whether they have a U.S. Fish and Wildlife Service permit.

The Department of Justice balances its commitment to accommodating the needs of federally recognized tribes with its commitment to enforcement of the Nation's wildlife laws. Thus, the Department of Justice will continue to prosecute tribal members and non-members alike for violating federal laws that prohibit the killing of eagles and other migratory birds or the buying or selling of such birds or the feathers or other parts of such birds. The terms "buying," "selling," and "compensation" include the exchange of federally protected birds, bird feathers, or other bird parts for cash, services, goods, or anything other than protected birds, bird feathers, or other bird parts.

The Department of Justice's Environment and Natural Resources Division (ENRD) and United States Attorneys' Offices work closely with the Department of the Interior's U.S. Fish and Wildlife Service on enforcement of federal laws protecting birds. It is a goal of both the Department of Justice and the Department of the Interior that these enforcement efforts

are carried out in a way that is consistent with the policies of both agencies, as described in this memorandum. Prosecutors should be aware that the Department of the Interior has a longstanding internal procedure regarding review of cases involving members of federally recognized tribes, which governs decisions by the Department of the Interior on the referral of cases to Department of Justice prosecutors.

United States Attorneys' Office

es shall consult with the Assistant Attorney General of ENRD or her designee, the Chief of ENRD's Environmental Crimes Section, if they have questions regarding whether particular conduct is consistent with this policy or whether exceptional circumstances exist. In addition, in light of the significant and important issues these cases raise, it is strongly recommended that Assistant U.S. Attorneys handling any case involving Native Americans and federally

protected birds, bird feathers or other bird parts, consult at an early stage of their investigation or prosecution with ENRD's Environmental Crimes Section. Among other things, prosecutors are strongly encouraged to consult with ENRD in any such case (involving Native Americans and federally protected birds, bird feathers, or other bird parts) in which an issue is raised regarding a treaty with an Indian tribe, the First Amendment of the United States Constitution, the American Indian Religious Freedom Act, or the Religious Freedom Restoration Act.

Consistent with the sovereign status of Indian tribes, and with this Department's commitment to fostering tribal self-determination, prosecutors are also encouraged to consider whether prosecution of particular cases would be more appropriately handled by tribal prosecutorial authorities in lieu of federal prosecution.

This policy is based on the special relationship that the federal government has with federally recognized tribes. This policy is not intended to address or change how the Department of Justice handles cases involving those who are not members of federally recognized tribes, including non-Indians or members of state-recognized tribes or other groups or organizations. The traditional elements of federal prosecutorial discretion continue to apply in all such cases. Prosecutors retain the discretion to consider all appropriate factors, such as the nature and seriousness of the offense and the culpability of the offender, in determining whether to pursue a particular prosecution that would not be inconsistent with this policy.

In exercising their discretion in such cases, prosecutors should be aware that it has been and continues to be the priority of the Department of Justice and the Department of the Interior to focus wildlife enforcement resources on those cases involving illegal activities that have the greatest negative impact on protected species, such as the unlawful take of protected wildlife and unlawful commercial activities involving protected wildlife.

This policy has been promulgated solely for the purpose of internal Department of Justice guidance. It is not intended to, does not, and may not be relied upon to create any rights, substantive or procedural, that are enforceable at law by any party in any matter, civil or Memorandum from the Attorney General.

"This administration has placed a high priority on strengthening the relationship with the state's sovereign nations, and I've made a personal commitment to step up efforts to increase achievement for American Indian students. Establishing this position and bringing someone with Dennis' skills and experience on board is key to those ongoing efforts."

Prior to working at the Department of Education, Olson served as the commissioner of education for the Mille Lacs Band of Ojibwe. He has also worked with the University of Minnesota, acting as a project coordinator for the Institute on Community Integration. Olson received his Master's in education and liberal studies with a concentration on Federal Indian Policy from the University of Minnesota-Duluth.

"There are many unique barriers facing today's American Indian youth. I am excited to work with Minnesota's American Indian communities to address these challenges and increase academic achievement and opportunity for all students," said Olson.

Olson is an enrolled member of the Fond du Lac Band.

## A meal without meat?

According to the guidelines for Cancer Prevention, people should limit their intake of red meat. There is convincing evidence that red meat (referring to beef, pork, lamb and goat from domesticated animals) is a cause of colorectal cancer. The guidelines recommend reducing red meat to less than 18oz a week. One way to start is to try one meatless meal each week. Build the meal around vegetables, beans, and grains instead of meat.

An average adult who consumes a 2000 calorie diet would need approximately 50-175 grams of protein a day (10-35% of total daily calories). The Dietary Guidelines for Americans recommends getting a variety of protein

from sources such as eggs, beans and peas, soy products and unsalted nuts and seeds.

Some examples of how to use alternative protein sources include using tofu in stir fries, casseroles, soups, or stews. Eggs can be scrambled, boiled, or fried. Beans are very versatile and contain a lot of fiber plus other cancer-fighting photochemicals. They can be mashed up to use as a dip or a spread. Add beans to soups, salads, or casseroles. Nuts provide protein, vitamins, and beneficial fats, but they are high in calories. Keep servings to a small handful. Nuts can be added to casseroles, sprinkled over salads, or ground up and used to thicken soups and stews.

Of course not all meals need to be meatless. Choose lean cuts and avoid oversized portions when meat is on

the menu. One serving of meat is about 3 ounces or the size of a deck of cards.

Cooking meat at high temperatures, especially over an open flame, can cause cancer-promoting substances called HCAs (heterocyclic amines) to form on the meat surface. To prevent HCAs and PAHs (polycyclic aromatic hydrocarbons) from forming try:

- Trimming the visible fat to prevent flare-ups
- Marinate the meat
- Pre-cook meats before placing on the grill
- Use aluminum foil or avoid placing meat directly over the open flame
- Cut away burnt or charred parts of the meat before eating.

- 1 Tbsp vegetable oil
- ½ medium onion, chopped
- For variation, add: ½ cup mushrooms, sliced and ½ cup green pepper, chopped
- 1 can (15-16 oz) kidney beans, drained or
- 1 ½ cups cooked beans
- 1 can (15-16 oz) stewed or diced tomatoes
- 1 tsp chili powder
- ½ tsp garlic powder
- 8 corn tortillas
- 1 cup Monterey Jack cheese, shredded
- No-stick cooking spray

1. Heat oven to 350°F.
2. Heat oil in frying pan on medium heat. Add onion and cook 2-4 minutes until tender.
3. Add beans, tomatoes, chili powder and garlic powder. Stir to combine.
4. Tear tortillas into bite-size pieces.
5. Layer ½ tortillas, ½ sauce and ½ cheese in 8-inch baking pan that has been coated with no-stick cooking spray. Repeat layers, ending with cheese.
6. Bake uncovered for 20 minutes.

## Flu Update 2012

Flu Season is once again upon us. Here are some updated facts and Frequently Asked Questions regarding this year's influenza vaccine:

### What is influenza (flu)?

Influenza is a contagious respiratory disease that can be prevented by immunization. It is not the same as the "stomach flu". Influenza is caused by a virus that attacks the nose, throat, and lungs. Symptoms come on quickly and include: fever, dry cough, sore throat, headache, extreme tiredness, stuffed up nose, and

body aches. These symptoms can be severe.

### How is the flu different from a cold?

A cold generally stays up in the head while the flu brings body aches, fever, and extreme fatigue. A person with a cold can usually keep up their normal daily activities, while someone with the flu will often feel too sick to do so.

### Who is most at risk for getting very sick from the flu?

- people age 65 and older
- infants/young children

- pregnant women
- people with certain health conditions such as asthma, diabetes, and heart disease
- Native Americans, African Americans, and Hispanic people.

### Should I get a flu vaccination this year?

Yes, everyone older than 6 months of age should be vaccinated. Even if you got the seasonal flu vaccine last year, you should still get vaccinated this year.

### Can you get the flu from the flu shot?

NO, some people do get mild flu-like symptoms for a short time after being vaccinated, but this is a sign that your body is responding to the vaccine and giving you protection. *It is not the flu.*

**Vaccinate Your Family-Protect Your Community:** Ask your provider for a flu shot or watch for upcoming community clinics and get vaccinated.

## A Wisconsin Fur Trader's Journal from 1803-04 by Michael Curot

The LaGarde family name goes way back and is mentioned several times in Michael Curot's journal from 1803-04. There are also many other old Fond du Lac names within the pages of this publication which can be found on the internet.

## Information from John Sayers' Journal 1805-1806

From a list of men in the North West Company's Fond du Lac Department for the year 1805 listed Joseph LaGarde as an interpreter. Then in 1806, Joseph LaGarde is listed as an interpreter in the Folle Avoine Department.

## 1865 – Duluth's First Census for the Town of Fond du Lac

Number 10 on the 1865 Fond du Lac Census for the city of Duluth is the John B. LaGarde family with wife Margaret and children Moses, Seymour, Paul, and Virginia.

Number 11 is the Joseph LaGarde family with wife Mary and child Joseph.

## 1877 Annual Genalogical Roll of the Fond du Lac Band Census

The head of family number 64 is John B. LaGarde who was 45 years old. He was the son of John B. LaGarde and Ashkwedjagon. John's sons are listed as Paul and Simon LaGarde whose mother is shown as Margaret Visinah.

## Joseph LaGord's death from the Duluth Courthouse Records

Joseph LaGord's death on March 27, 1885 is recorded in the Duluth Courthouse records. He was born in Fond du Lac and died at the age of 60. His parents are noted as John and Mary LaGord who were both born in Fond du Lac. Keep in mind there are many spelling errors in historical records.

## List of Allottees of the Fond du Lac Band from Nov. 23, 1889

Number 355 is Paul LaGarde and 356 is John LaGarde. They were allotted land in Section 13, Town 50 and Range 18.

## 1908 Census for Fond du Lac

Number 501 is Mrs. Ella La Garde who is 35 years old. Her children are listed as George age 15, Frank age 12, Matilda age 11, Cynthia age 9, Elias age 8, Freda age 5, and Kwe sense age 1.

## Buried with Indian Rites is the Heading of the Obituary of John Lagarde from the Duluth News Tribune of Feb. 28, 1911

*John Lagarde, the aged Chippewa Indian trapper, who died yesterday at Fond du Lac, will be buried with Indian rites and ceremonies Thursday at the Fond du Lac Indian reservation near Cloquet.*

*Among the Chippewas, Lagarde was known as Ak-i-wenci, meaning "an old man." His exact age is not known, but it is thought that he was close to 101 years old.*

*According to the most reliable information, Lagarde was born about 100 years ago on the Red Lake Indian reservation near Thief River Falls. His mother was a full-blooded Chippewa and his father a half breed with a French-Canadian name. In 1834, when about 24 years old, he came with his mother to the Head of the Lakes and settled at the historic John Jacob Astor trading post at Fond du Lac.*

*Three years later while trading at Madeline Island, near Bayfield, he met Liola Chievier, a half-breed, whom he afterwards married and brought to Fond du Lac. They lived for years on eighty acres of land, which is now the property of the Steel corporation and will be used as a site for the new steel plant.*

*There were seven children to this union, but only three are now living.*

*The youngest, aged 55, lived at Fond du Lac with his father. The other two are located on the White Earth reservation. They are Moses and Simon.*

## Clara Stocker's Diary from 1916 and She Talks about John LaGarde and Joseph Sherrette

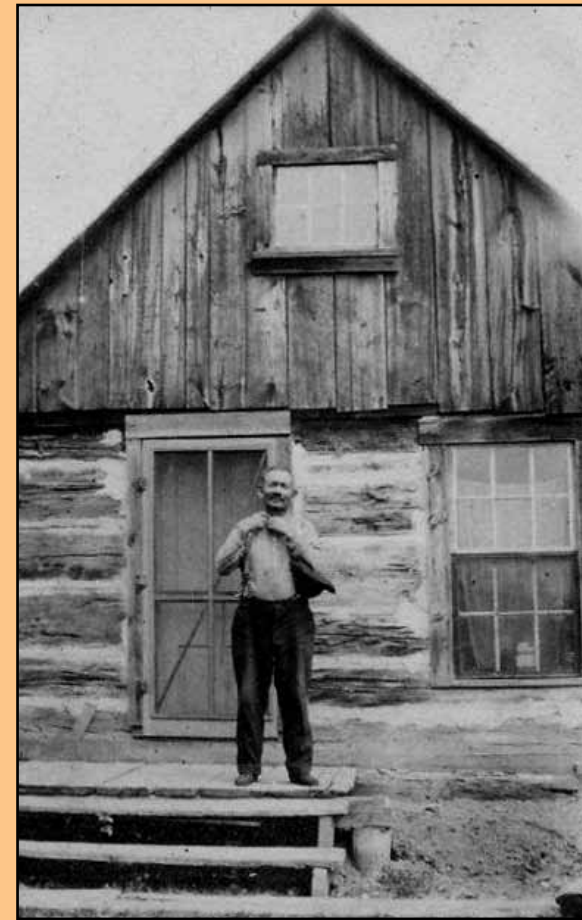
*Went to Fond du Lac for trilliums (Clara, Mrs. Hansen, Dr. McCoy and I). Left the others and went to call on LeGarde who is an old Indian and lives alone in a log hut. He is very deaf. I took his picture. He took me to a white house near by to call on Joe Sherrette. He is also an old Indian. His grandfather was French. He remembers the time when as he said "Wigwams were all over here" – Fond du Lac". He once went to Cloquet where so many Indians are and worked with the logs But, he said, "I thought of Fond du Lac all the time and when the log sawing was over I skipped back to Fond du Lac and I have stayed here all the time since."*

## Well Known Indian Guide Passes Away – 1917

*Paul Le Garde, age 60 years well known in the suburbs as an Indian scout and guide, died at the Duluth hospital yesterday following an illness of about two months. The funeral will be held tomorrow morning at 9 o'clock from the Indian Reservation church at Cloquet.*

*Mr. Le Garde was born in Fond du Lac. His father, John Le Garde, who died four years ago, was also born at this place and was trader and scout for many of the earliest settlers at the Head of the Lakes. Paul had for more than forty years followed similar occupations. He continually made his home at Fond du Lac. He was a member of the Old Settlers' association.*

*Carlson is my maiden name and our family lived in Fond du Lac on Paul Ave. also known as 131st Ave. West. The John and Paul LaGarde family property was across the street from where I grew up.*

## Hunting Season Update

Fond du Lac's Reservation and Ceded Territory are well under way. As of the end of September; 4 bear and 1 turkey had been registered. Bear harvest by FDL members typically ranges from 0-6 animals each fall. By the middle of October, bears are starting to enter their dens and most are hibernating by the first part of November. Turkeys could be encountered at any time, but fall turkey hunting pressure is usually very light.

By the end of September, FDL hunters had registered 25 deer from the Reservation and the 1854 and 1837 Ceded Territories of Minnesota as compared to 15 deer for the same period in 2011. Hunters should expect to see a few more deer in the woods this fall following last year's mild winter.

New for FDL hunters in 2012 is access to the Ceded Territories of 1837 and 1842 in Wisconsin and Michigan. A few FDL hunters have been going across the border to get their deer. Historically, about half of FDL's total deer harvest takes place during the first 3 weeks of November. The Reservation and Ceded Territory deer seasons close Dec. 31.

Fond du Lac's moose season opened Sept. 22. In 2012, 72 permits were available to FDL band members, but the harvest was limited to bulls only. As of Oct. 9, 16 moose had been registered by FDL hunters, ahead of last year's pace when only 12 had been registered by this time. Last year FDL hunters took 18 moose for the season. FDL's moose season continues through Dec. 31.

Waterfowl and hunting and trapping seasons for most small game species are open as well.

## October Canning Class

13 Moons and the Bimaaji'idiwin Ojibwe Garden program hosted a canning workshop at the Cloquet Community Center on Oct. 9. Mary McConnell was our expert canner who spent the better part of the day teaching us canning. Danielle Diver had purchased some of McConnell's chow chow, a pickled relish made of cabbage, cauliflower, green tomatoes, and peppers and found it to be so tasty we used the recipe for demonstration at the canning workshop. We also canned applesauce

using a quick and easy recipe adding a dash of cinnamon and cloves to add a homemade flavor without adding sugar.

Dave Wise, Fond du Lac community member, talked about his experiences learning how to can venison, moose, and fish. Wise also demonstrated how to check the gauge of a pressure cooker.

included Hidatsa squash soup made by Danielle, venison stew provided by Wise and I made (out of the box) pumpkin muffins with dried cranberries and walnuts added. We had 10 participants from the Fond du Lac and Cloquet community attend the workshop and everyone went away with a jar of chow chow or applesauce. It was a great evening sharing stories of hunting, gardening and canning. The plan for next year is to have community members bring in their own produce so they can learn the process step by step.

## Anishinaabemowin Lessons

Consonants used in Ojibwe make nearly the same sounds that they do in English. The Vowels are a little different though. Here they are:

i = ih (like the 'i' sound in 'it')  
 ii = ee (like the 'e' sound in 'see')  
 o = o (like the 'o' sound in 'oh')  
 oo = oo (like the 'o' sound in 'boo')  
 a = ah (like the 'u' sound in 'but')  
 aa = aa (like 'a' sound in father')  
 e = ay (like the 'a' sound in 'say')

### Basic Rule for Ojibwe:

Gii = Past tense maker  
 Wiisini = 'S/he is eating.'  
 Gii-wiisini = 'S/he ate.'  
 The past tense marker gii- turned 'S/he is eating' to 'S/he ate'. Try practicing with other action words like eating, running, walking, etc.
